Services Required

The District of Clearwater is requesting quotations for supply of 2 combination garbage recycling dumpsters and for weekly garbage removal at 2 sites, North Thompson Sportsplex and Dutch Lake Community Center.

Scope of Work

1. Supply 2 (two) split dumpsters for garbage and recycling at 2 (two) work sites.
2. Dumpsters to be minimum 230 cubic feet in size. Must have lids, center divider and split dump gates.
3. Dumpsters to be emptied weekly.
4. This is a 3 (three) year contract that may be extended for an additional 2 (two) years by mutual agreement.
5. Quote to include bin rental fee and bin dumping fee
6. There will be no markup on tipping fees.

There is no site visit planned.

Evaluation Criteria

Evaluation Criteria is solely based on price.

- There is to be no mark up on Tipping fees charges.
- The successful proponent will be required to hold a Business license with the District of Clearwater
- The successful proponent will be required to provide proof of General Liability Insurance of Five Million Dollars (\$5,000,000).
- The successful proponent will be required to provide proof of vehicle insurance and Work Safe BC clearance.
- Either party can void this contract with 15 day's notice.
- Work site to be left in a clean and professional manner.
- Proponent staff to conduct themselves in a professional manner when dealing the staff and public.
- Invoices to be submitted bi-weekly with copy of Tipping fees receipt attached.
- payments to be made within 30 days.
